- Because we are determined to provide safe and healthy drinkable water to every household in India.


With this vision in mind, we are pleased to introduce "Mission Jaldhara"

High Court grants relief to sellers for 156 banned pharma products

The Indian Federation of Pharma Generics (IFPG) has welcomed a decision by the Delhi High Court, which has provided relief to sellers affected by the August 12, 2024, notification that banned the sale of 156 pharmaceutical. the sale of 156 pharmaceutical products. The High Court's stay order allows sellers to continue selling their existing stock of these products. IFPG had filed an appeal with the Delhi High Court on behalf of

various generic
pharmaceutical companies,
requesting the court to allow
them to sell their current stock
rather than destroying it. The
court's decision has been met
with relief by the industry. with relief by the industry. Gyanesh Jeswal, the Secretary-General of IFPG, expressed gratitude for the court's decision, stating, "We welcome the court's ruling,

which ensures that patients continue to have access to these trusted treatment options." He emphasized that IFPG represents over 156 pharmaceutical companies engaged in the research, development, manufacturing, and marketing of generic drugs in India. The organization is committed to

promoting affordable and high-quality healthcare solutions both within India Numerous prominent pharmaceutical companies, including Liford Healthcare,

Smartway, Smart Laboratories, Cadila Pharma, Curatek Group, Morvin India Laboratories, G Laboratories, Syncom, Coron Remedies, Microlab, Bokard, Master Health Innovation, Alba Debit, Jackson Pal, Bestochem, Biochem, Indico, and Angle-French baye and Anglo-French, have welcomed the High Court's decision in line with IFPG's stance. Sumit Singla, the Vice President of IFPG Himachal Pradesh, IDMA member, and Menseine Director of Currell. Pradesh, IDMA member, and Managing Director of Curatek Group, also praised the High Court's stay order. He urged all manufacturers affected by the ban on the 156 pharmaceutical products to unite and file appeals with the High Court. He highlighted the importance of this collective action to prevent the loss of raw materials and packaging stock worth crores of rupees.





FII joint delegation visit Rashtrapati Bhavan in New Delhi on 20th Sep. 2024











WHAT IS THE DIFFERENCE BETWEEN DEFENCE DIPLOMACY OF INDIA AND CHINA??

hile on one hand, China's defence

diplomacy is continuously trying to maintain its dominance in the Middle East, on the other hand, China's defence diplomacy is also expanding rapidly in all our neighbouring countries and its impact can be clearly seen on the ground as well. Its latest quote is that Afghanistan, Bangladesh and Pakistan have been sometimes in the hands of Russia, sometimes America and sometimes China for the last 50

years. Now it seems that America and China are seen face to face, but in order to remove Russia. America itself is giving strength to China by leaving it everywhere.

Now we should also take a look at where India is. Just as almost all countries are increasing their focus on defence diplomacy, India too is expanding in this segment. African countries are also included in these. This includes Poland as well as Algeria, Djibouti, Ivory Coast, Spain, Armenia, Mozambique, Ethiopia, Tanzania. Army officers have been sent to four out of 10 places, Navy

officers to three places and Air Force officers to three

places. According to sources, defence wings have

been opened at almost all these places or the process of opening them has been completed.

Through defence diplomacy, India focuses on programs like joint exercises, training exchanges with other countries and through this we also get experts from those places. If ever there is a need to perform any operation there in future, we will also have area experts there. Besides, the military industry everywhere is also growing. It is also important to learn new techniques and new tactics from each other. India is also trying to export indigenous Tejas fighter, rocket launcher system, BrahMos missile, air

defence missile system to African countries.

Indian public sector companies operate in more than 30 countries around the world such as Thailand, Malaysia, Indonesia, Sri Lanka, Bangladesh, Germany, Belgium, Turkey, Egypt, Oman, Israel, Kenya, Nigeria, Botswana, Chile, Suriname and the United States. The exports include arms and ammunition, weapon

parts, chemicals and explosives, parachutes, leather and clothing items.

However, India's defence exports have seen a huge



increase since 2014 due to the opening up of the defence sector by Prime Minister Narendra Modi's government. According to the latest official data tabled in the Rajya Sabha – the upper house of the Indian Parliament, India's defence exports have increased by 700% in just two years. Export authorizations increased from US\$213 million in FY 2016-17 to \$1.5 billion in FY 2018-19 (April to March period). Stockholm International Peace Research Institute notes that there are three Indian companies among the top-100 defence companies, namely Hindustan Aeronautics Limited, Avani and Bharat Electronics Limited, which together account for 1.2% of the top-100's total defence exports.

In March 2011 New Delhi agreed to sell its first indigenously designed and built multi-role offshore patrol vessel (OPV), Barracuda, to Mauritius. In March 2017, India finalised a US\$37.9 million deal with Myanmar for the sale of indigenously developed lightweight torpedoes. Similar naval platforms were also sold to Sri Lanka and Vietnam. Thailand has also purchased more than 600 military trucks from India. Recently Armenia has also emerged as a strategic partner for India. In 2022, India has signed a deal to supply Pinaka multi-barrel rocket launchers (MBRLs), anti-tank munitions and ammunition worth US\$250 million to Armenia.

While in September 2017, AWE won its largest export order from the UAE for the supply of 40,000 nos of 155 mm artillery shells for 3.22 billion (US\$39 million), in August 2019, AWE won the supply of 50,000 nos of artillery shells from the UAE.

The Defense Ministry's Year-End Review 2023 said total exports for fiscal year 2022-2023 stood at Rs 16,000 crore. It involved 85 countries and marked a tenfold increase from fiscal year 2016–17. Major

platforms exported include Pinaka multi-barrel rocket launchers, radars, simulators, mine protected vehicles, armoured vehicles, line replaceable units and parts, thermal imagers, body armour, ammunition, small arms and avionics components. Other platforms include the Dornier-228, 155 mm/52 calibre DRDO Advanced Towed Artillery Gun System, BrahMos cruise missile and Akash SAM.

Defence exports totaled Rs 21,083 crore (about \$2.63 billion) in FY 2023-2024, an increase of 32.5 percent from the previous fiscal year. That is, there is no freefree system here. India does not want to occupy other countries unlike China or America, but by cooperating with them, we are playing an important role in empowering them. There is also an identity as there is neither anything free in our diplomacy nor is everyone allowed to buy all types of our weapons. Indian Government has moral parameters of its own that our weapons cannot reach any terrorist organisation whereas we all know where Made in America and Made in China weapons are being found. Even though India is taking forward its defence diplomacy in a very cautious, slow but effective manner where it is not making enemies but making friends, it has been seen that the big superpowers of the world are promoting enmity for the expansion of their respective defence industries. But India is engaged in carrying forward its defensive defence diplomacy with other countries to enhance their self-defence and protect sovereignty.

Such events underscore how local climate events can have farreaching effects on global markets, disrupting trade and exacerbating food price inflation. These price shocks particularly hurt the poorest populations, who are less able to cope with rising food costs. Moreover, they can lead to inflationary pressures on the broader economy, affecting everything from the cost of food to the stability of national currencies.



Economic Impacts on Rural Areas

The agricultural sector is a major employer, especially in rural areas of developing countries. As climate change reduces the viability of farming in certain regions, rural economies face severe economic strain. Farmers who rely on traditional methods of cultivation are the hardest hit, as they lack the resources to adapt to new climate realities. In many cases, the damage to agriculture could become a selfperpetuating cycle, where reduced crop productivity leads to higher food prices, increased poverty, and lower economic growth. On the flip side, countries that are able to adapt their agricultural practices could benefit from climate change. For instance, regions in the Northern Hemisphere might see longer growing seasons due to warmer temperatures. However, the costs of adaptation—such as investing in new technologies, irrigation systems, and drought-resistant crops—are

significant and may not be affordable for all nations.

To mitigate the economic impact of climate change on agriculture, governments and international organisations must invest in climate-resilient agricultural practices. This includes promoting the use of drought-resistant crops, improving irrigation infrastructure, and supporting agricultural research and innovation. Additionally, global cooperation is essential. Trade policies must be adapted to allow countries to access food in times of shortage, while international aid and investment are crucial for helping developing countries transition to more sustainable agricultural practices. 
Historian Makrand Mehta, 93, passes away in Ahmedabad

ocial and business historian Makrand Mehta, 93, passed away Sunday morning at a private Ahmedabad hospital where he was admitted a day before due to suspected dengue. A professor emeritus of history, Gujarat University Ahmedabad, Mehta was associated with several academic institutes, literature and history bodies. Active till his last days, Mehta who was born into a Nagar Brahmin family on May 25, 1931 revisited his birthplace at Vageshwari Pol in the city's walled area of Khadia only a fortnight back. Mehta is survived by his historian wife Shirin and two sons — Sangam and Ankit — who reside in Mumbai and Ankelshwar respectively.




